(the “**Issuer**”), (ii) beneficial owners of the Notes, (iii) bona fide prospective investors in the Notes, (iv) bona fide securities analysts (to the extent providing analysis of an investment in the Notes) and (vi) bona fide market makers in the Notes affiliated with an initial purchaser of the Notes.

By requesting access to this information you represent to and covenant with the Issuer that:

1) you are either (a) (i) a holder of the Notes, a beneficial owner of the Notes, a bona fide prospective investor in the Notes or a bona fide market maker in the Notes affiliated with an initial purchaser of the Notes and (ii) either a “qualified institutional buyer” (QIB) as defined in Rule 144A of the Securities Act of 1933, as amended (the “**Securities Act**”), or not a “U.S. person” as defined in Rule 902 of the Securities Act, or (b) a bona fide securities analyst providing an analysis of an investment in the Notes;

2) you will not use the information in violation of applicable securities laws or regulations; and

3) other than in the case of securities analysts, you will keep such information confidential and will not communicate the information to any individual, corporation, partnership, joint venture, association, joint-stock company, trust, unincorporated organization, limited liability company (or series thereof) or governmental agency or political subdivision thereof or any other entity and (x) are not a competitor of the Issuer and its subsidiaries and (y) will not use such information in any manner intended to compete with the business of the Issuer and its subsidiaries.

The undersigned understands that it is providing the information, contained herein, solely for purposes of enabling the Issuer to determine whether the undersigned should receive access to the Data Site. This letter is neither an offer to purchase, nor exchange any securities, including the Notes, nor creates any obligations whatsoever on the part of the Issuer or the undersigned to sell or purchase any securities.

This request for information shall be governed by, and construed in accordance with, the laws of the State of New York without regard to any conflict of laws principles thereof. Any action brought in connection with this request for information shall be brought in the federal or state courts located in the Borough of Manhattan in the City of New York, and the undersigned hereby irrevocably consents to the jurisdiction of such courts and waives any objections as to the venue or inconvenient forum.
